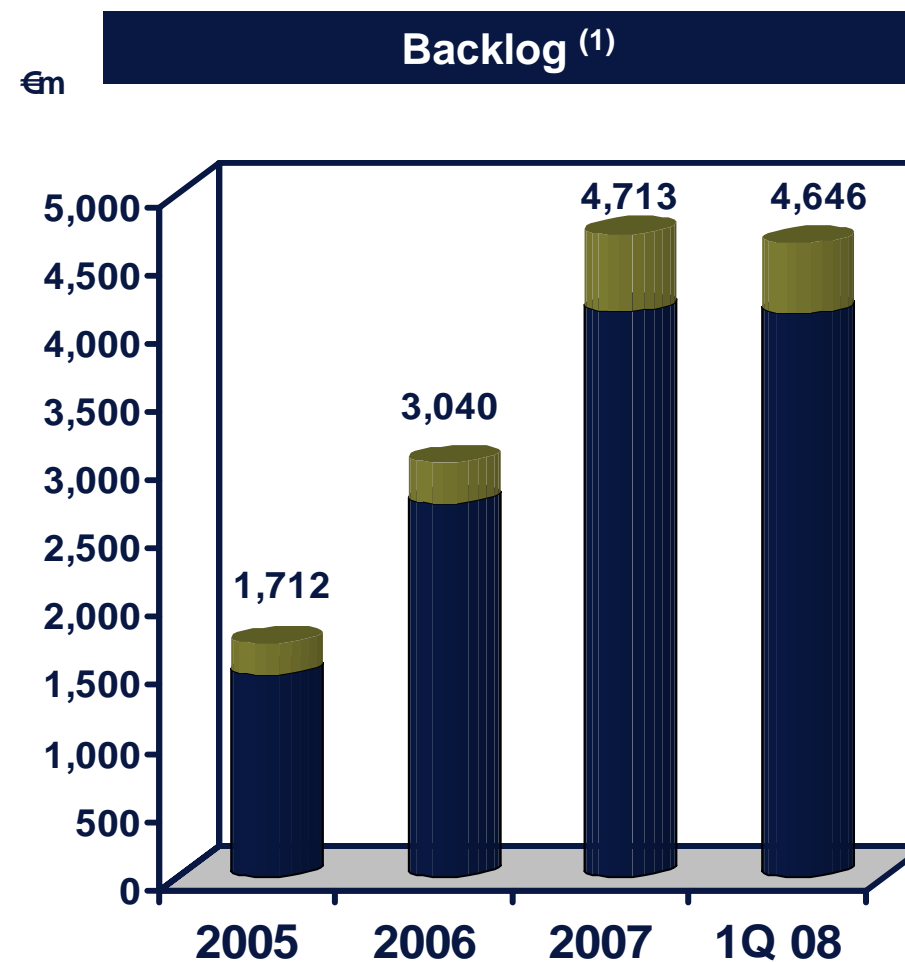
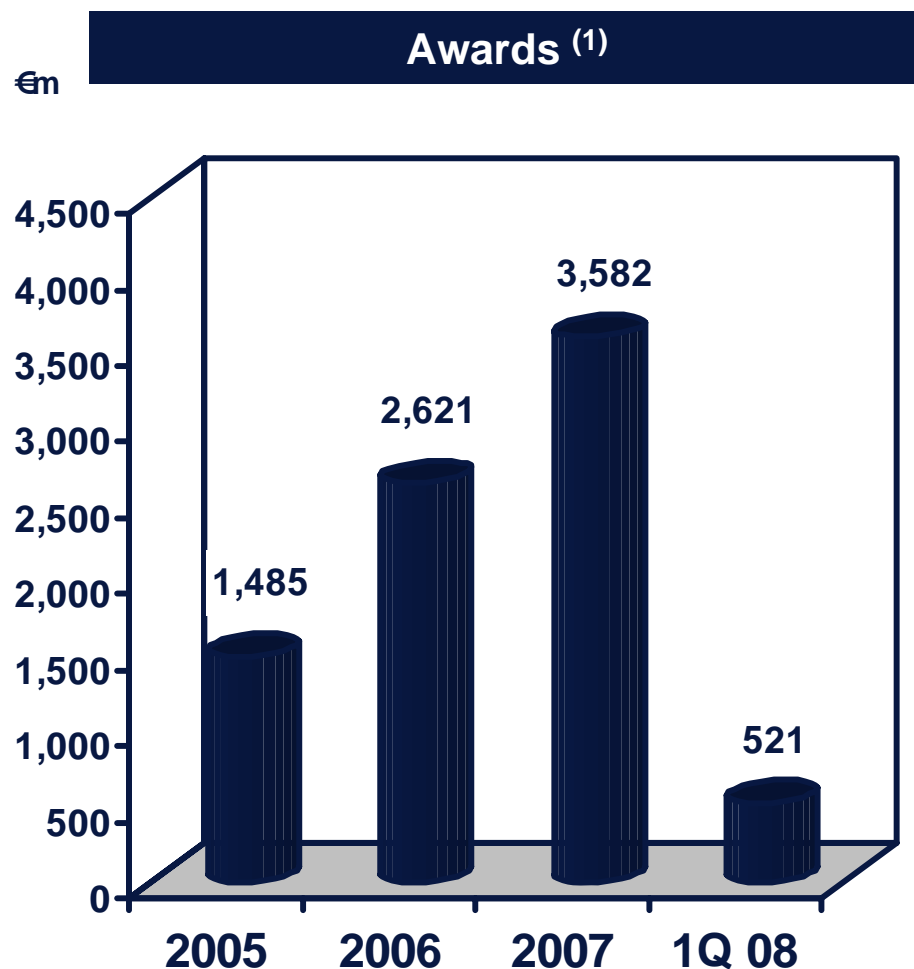

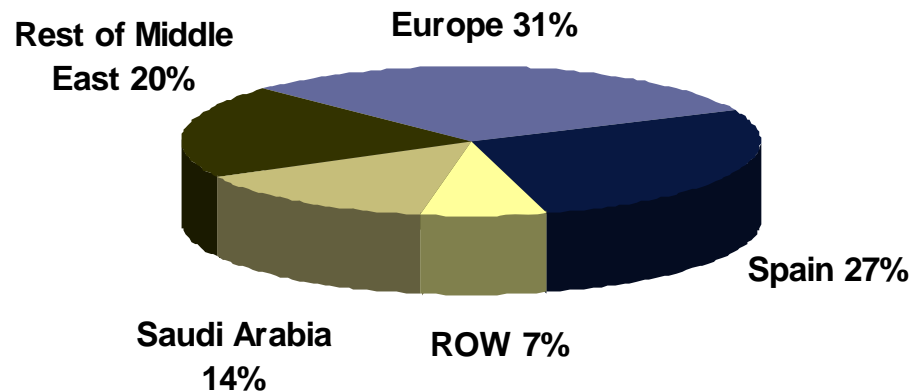

Elefsina's Refinery Upgrade (Greece)



Highlights



- Service Contract for TR
- The project involves a hydrocracker unit (40,000 bpd), a flexicoker unit (20,000 bpd), a vacuum distillation unit (45,000 bpd) and a hydrogen unit (120,000 m3/h)
- The hydrocracker will be the 22nd designed by TR. The flexicoker, licensed by Exxon, will be the sixth of its kind in the world and the second in Europe. TR will become the second company in the world to design a flexicoker.
- Hellenic Petroleum S.A. (Helpe) is the leading Greek refining & marketing company, with three out of four refineries in Greece, supplying 73% of the local oil products demand.
- Investment above €1,000 million, the largest for Helpe to date.

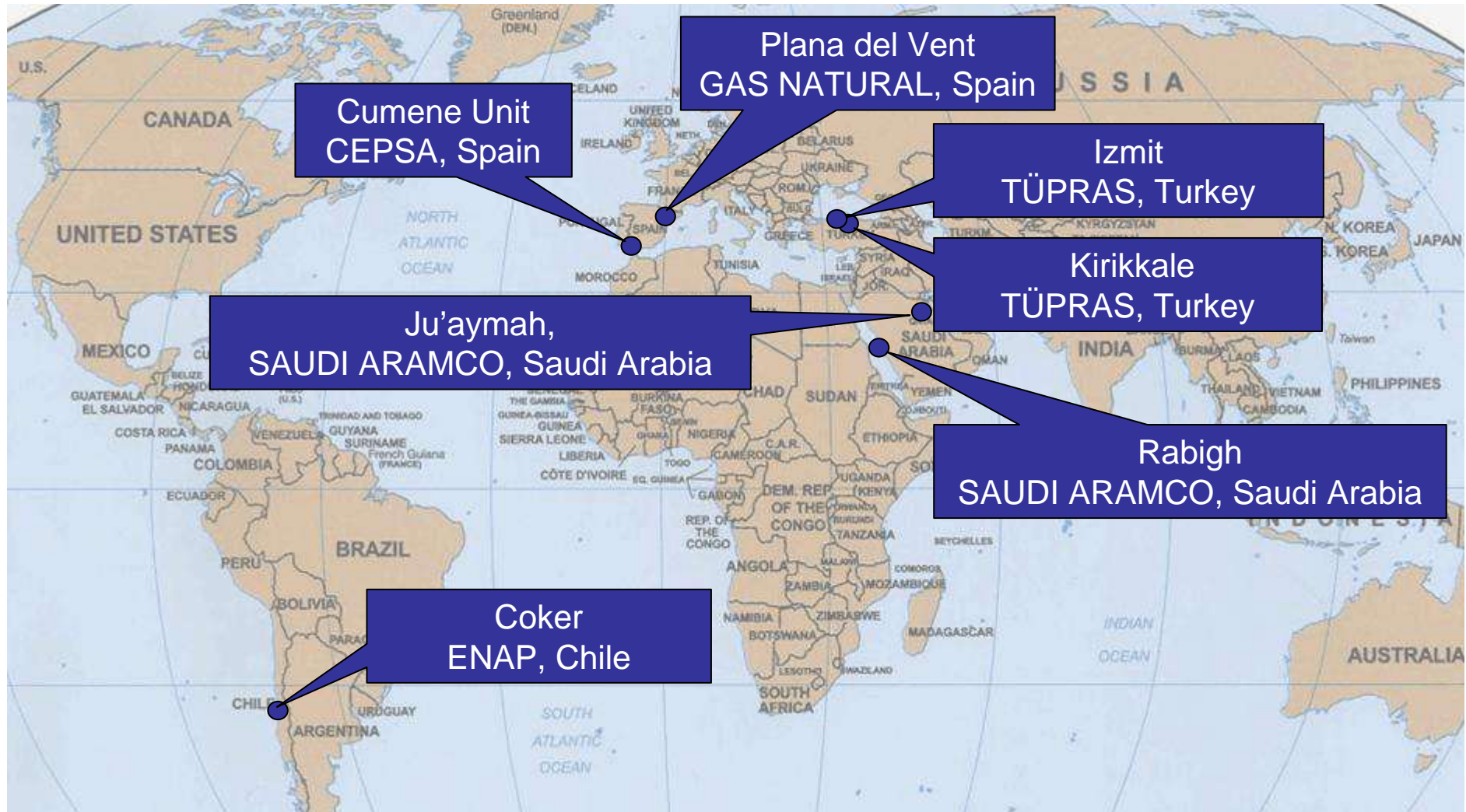

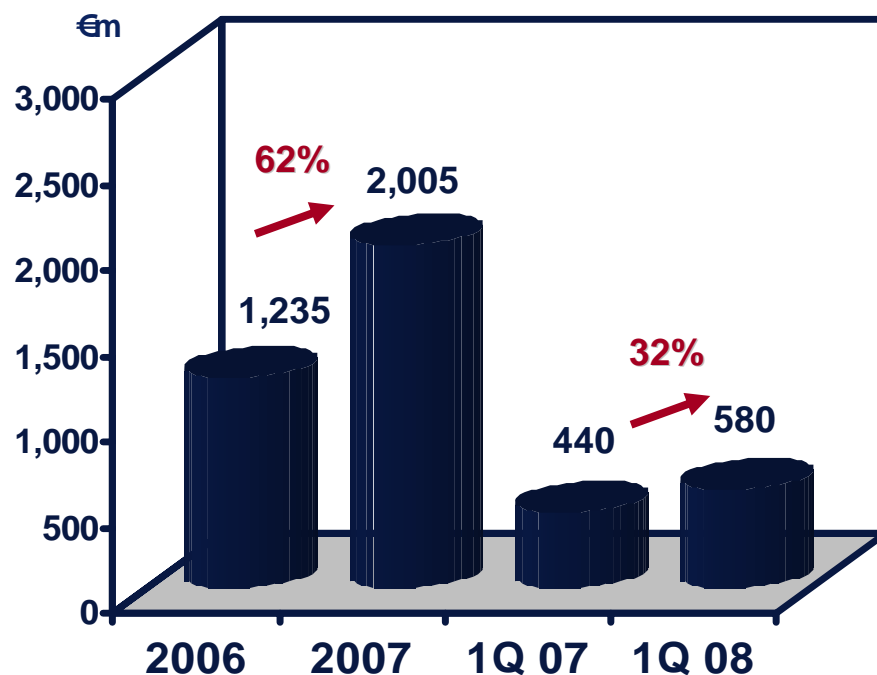

SALES and EBITDA GROWTH

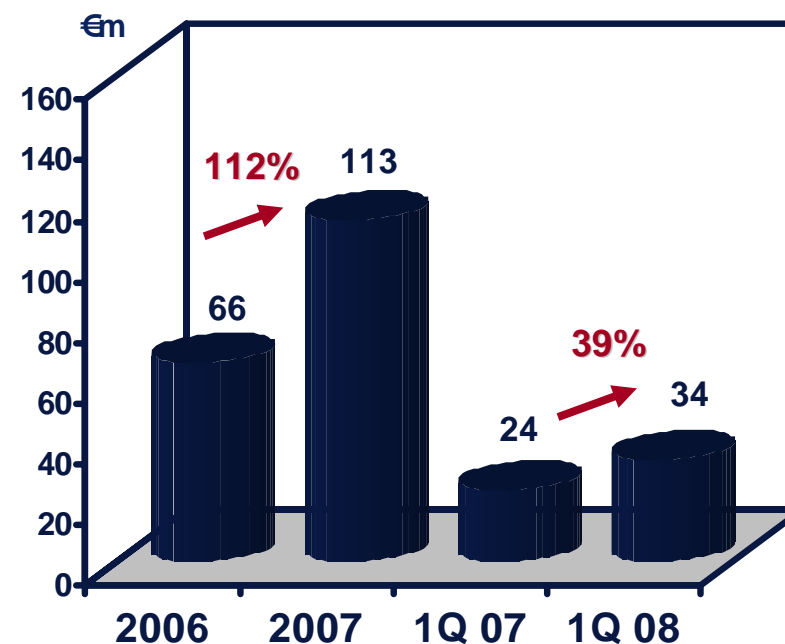

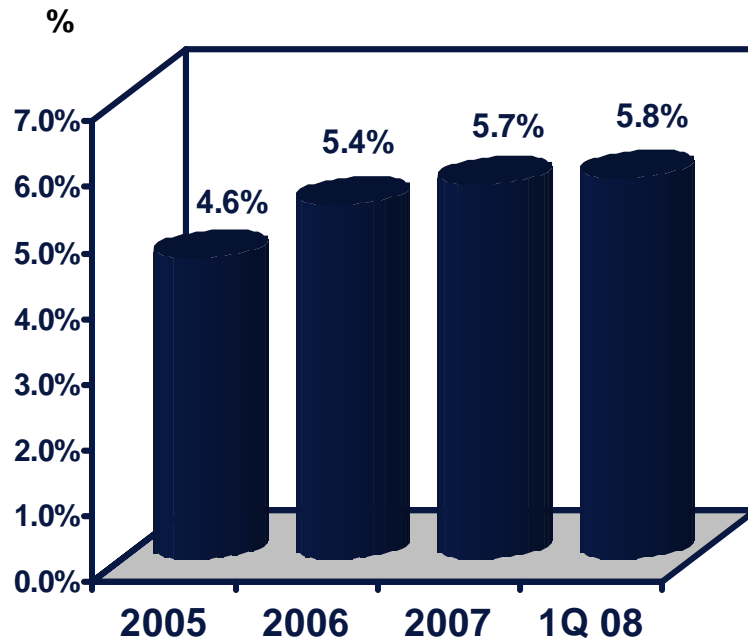


EBITDA

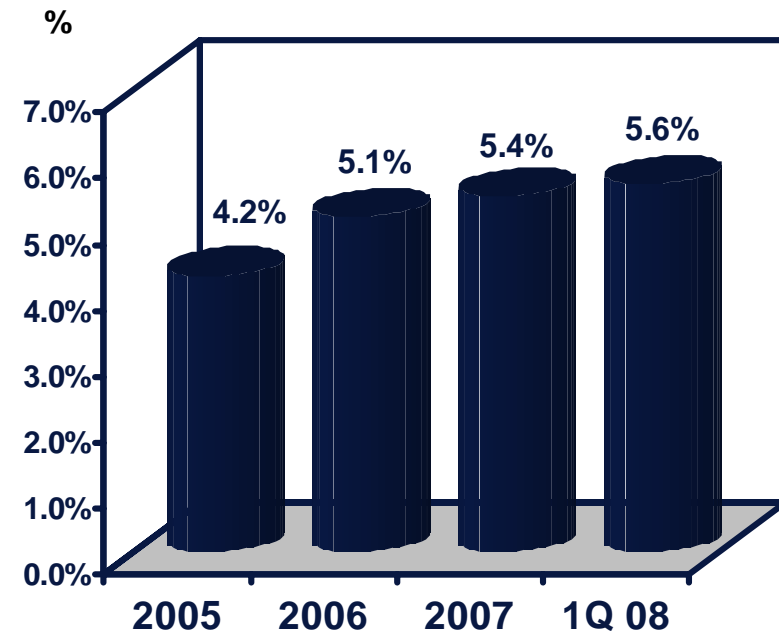

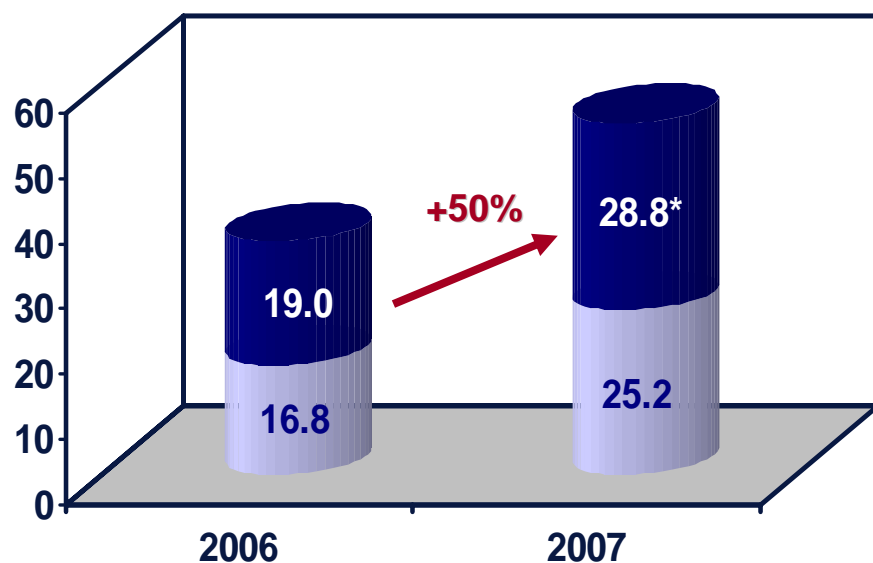

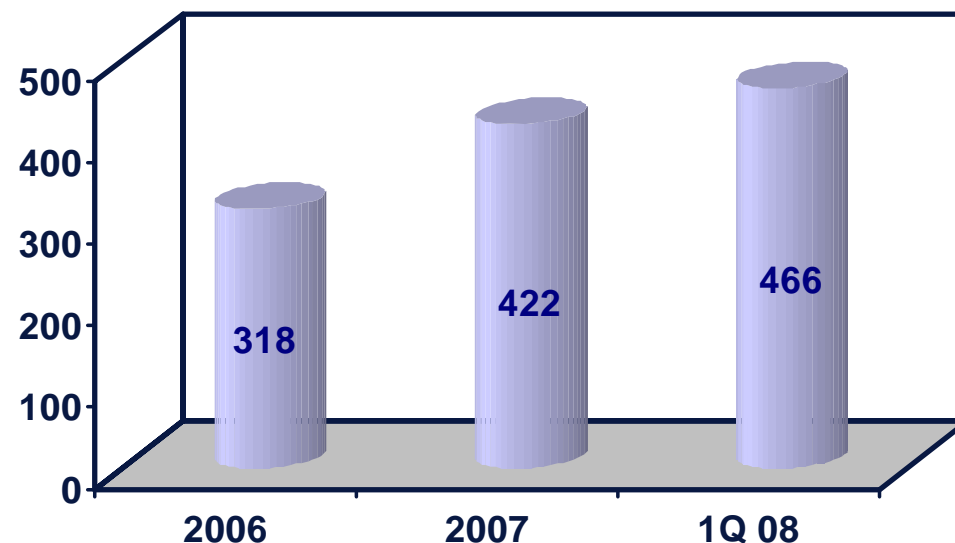
